Property owned by you and located near the noise source, may be affected by this variance request. ## **Description of Variance:**

Noise Source: Friends of Rebecca Noecker have requested a sound level variance, at a requested sound level limit of 92 dBA at 100 feet in order to present amplified DJ music, with speakers, from 4:00 p.m. until 6:00 p.m., with a pre-event sound check at 3:00 p.m., on Sunday, August 5, 2018 at 781 Palace Avenue. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified DJ music with speakers for the hours from 4:00 p.m. to 6:00 p.m., with a pre-event sound check 3:00 p.m., on Sunday, August 5, 2018. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA at 50 feet from the noise source from 4:00 p.m. until 6:00 p.m., with a pre-event sound check at 3:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 6:00 p.m. on Sunday, August 5, 2018.
