#### Dear Property Representative:

A re-inspection was made on your building on January 17, 2018, in response to a complaint. You are hereby notified that the following deficiencies must be corrected prior to re-inspection date.

### A re-inspection will be made on June 14, 2018 at 10:30 pm.

Failure to comply may result in a criminal citation or the revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

#### **DEFICIENCY LIST**

- 1. Exterior SPLC 34.08 (7) All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-8989. The asphalt driveway has deteriorated and in need of replacement.
- 2. Interior Basement MSBC -Section 105.1 Permits Required. Any owner or authorized agent who intends to construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure, or to erect, install, enlarge, alter, repair, remove, convert or replace any electrical, gas, mechanical or plumbing system, the installation of which is regulated by this code, or to cause any such work to be done, shall first make application to the building official and obtain the required permit. Work being done requires a permit. The permit for the hot water heater needs a final inspection and the file closed, contact your contractor to arrange the final inspection.

You have the right to appeal these orders to the Legislative Hearing Officer.
