Sound Level Variance – Team Ortho Foundation Women Rock Race and Pre-Race Event

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Description of Variance:

Location: Shepard Road between Eagle Street and Walnut Street

Noise Source: Team Ortho Foundation has requested a sound level variance, at no specified sound level limit, to provide the use of a sound system for pre-race and race announcements on Shepard Road between Eagle Street and Walnut Street for the Women Rock Run event. The variance is requested for the hours of 7:30 a.m. until 1:30 p.m., with a pre-event sound check at 7:15 a.m. on Saturday, August 25, 2018. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 7:30 a.m. to 1:30 p.m., with a pre-event sound check at 7:15 a.m. for the Event on Saturday, August 25, 2018. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:30 p.m. on the date of the event.
