An inspection was made of your building on May 1, 2018 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately.

A reinspection will be made on June 8, 2018 at 1:00 PM.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- 1. Exterior Garage & Fence SPLC 34.08(5), 34.32(3) All accessory structures including, but not limited to, detached garages, sheds and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements. -The garage has chipping and peeling paint, there is a window with a hole on the sash. The fence at the front of the property has been reinstalled but drags on the ground.
- 2. Exterior Near Garage SPLC 45.03 (7) Cut and maintain the grass/weeds less than 8 inches tall. -There is a tree next to the garage that is rubbing against the garage and damaging the side.
- 3. Exterior Parking Surface SPLC 34.08 (7) All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-8989.-The entire parking surface and driveway is in disrepair. The front portion of the cement driveway has deteriorated and is no longer maintained. The parking surface near the garage has large cracks, holes and damages.

4. Exterior - Sidewalks & Stairs - SPLC 34.08 (10) - Repair, replace and maintain exterior sidewalks, walkways and stairs.

The sidewalk on the side of the house is cracked, damaged and have sharp edges on the sides and the small sidewalk near the back is worn.

There is a large hole in the front concrete stairs.

There is a large section of the sidewalk near the fence that is in disrepair and is heaved.

5. SPLC 39.02(c) - Complete and sign the smoke detector affidavit and return it to this office.
