





Details of Conversations (Statements to and by Person Responsible for Property): Site visit on 5 June 2018, found 1 violation #7, I also observed the cars on the premises, and took photos, I had a verbal conversation over the phone with Mr. Cano to inform him of the problem and I advised him that I would re-Inspection in seven days. I returned on the 13th of June no violations found. I went through the license conditions with the manager Greg, and told him I would be back in ten days for another inspection. When the owner renewed his license, he informed me that he would not be available on that date, but he would be on June 20th at noon. I advised him the vehicles on premises cannot remain longer than 10 days per conditions or that would be a violation. I returned to the property to discover that the vehicles were still on site, violation #11, customer vehicles may not be parked longer than ten days.
