NOTICE OF PUBLIC HEARING

Sound Level Variance Beats in Boyd

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance

Location: Boyd Park, 335 Selby Avenue

Noise Source: B Horst Productions, Beats in Boyd, has applied for a Submission 2 sound level variance, at a requested sound level of 90 dBA at no specified distance, in order to provide music outdoors at Boyd Park, from 6:00 p.m. until 10:00 p.m., with a pre-event sound check from 5:00 p.m. until 6:00 p.m. on three (3) Fridays, September 7, September 14 and September 21, 2018. The Department of Safety and Inspections recommends the following conditions: 1) Variance will be for amplified music for the hours of 6:00 p.m. until 10:00 p.m., with a pre-event sound check from 5:00 to 6:00 p.m., on three (3) Fridays, September 7, September 14 and September 21, 2018. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA, as measured at 50 feet from the noise source from 6:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on each event date.
