This matter was decided by the City Council on July 11. An extension was granted to have the power restored or vacate the premises by August 9. I do not believe the Council would entertain an additional extension, as there was an amendment to give 2 weeks beyond my recommended vacate date of July 26, which was already more than a month after the DSI recommended date to vacate of June 21.

I think the best way to restore Xcel service will be to file a bankruptcy. I found a lawyer who's willing to do it. I have to reach the client and get them connected so they can get all the preliminaries done.

I understand the place is supposed to be boarded up tomorrow. I am wondering if we could get an extension so we can get the bankruptcy filed and the power restored. Two weeks would be ideal but we can likely make a shorter time work if necessary.
