Hi All,

At yesterday's Council public hearing on the order to remove/repair this building, the owner of 877 Woodbridge Street, Ling Jian Zhou, showed up to say he wants to rehab this building. He didn't show up at the Legislative Hearing, so we had somewhat limited information to go on. What is apparent is that the last interior inspection was conducted in 2012 and since he says he's almost done, the City Attorney would like us to get a clear idea of current conditions on the inside to verify or disprove his claim. That way the Council's decision will better-informed, and if necessary, we'll be in a better place for Appeals Court. The Council laid the matter over for 1 week.

I briefly met with the owner after the meeting and told him that he needed to get in today (Thursday) to make application for a code compliance inspection report. He was told that if he did not, the Council would order it at its meeting on 8/22, and noncompliance would likely result in the removal of the building. I also told him he needed to post the \$5,000 performance deposit within the next few days.

## 3 things:

- 1) Is there any way this inspection could be expedited? I don't think it needs to be written up in time for the 8/22 meeting, but the sooner we get it, the sooner we can hold him accountable.
- 2) Do you have the information you need to gain access (a keybox code or...)?
- 3) Can I get a copy of the application for the inspection emailed to me for our records?

I'm sorry to have a pressured request, but it seemed to shake out that way on this one.
