So that the Department of Safety and Inspections (DSI) may continue processing the renewal of this expired license, you must complete the following actions by <u>08/06/2018</u>:

- Provide evidence of insurance issued by an insurance company authorized to do business in the State of Minnesota, insuring said applicant in a sum of at least one hundred thousand dollars (\$100,000.00) for bodily injuries to or death of any person or persons not covered by the workers' compensation law, and in a sum of at least one hundred thousand dollars (\$100,000.00) for damage to or destruction of property

NOTE: New vehicle(s) require a visual inspection conducted by a DSI Inspector with the initial licensing of the vehicle(s). A current MN DOT inspection report may be submitted with future renewals of a previously DSI inspected & licensed vehicle (unless changes have been made to the vehicle or is otherwise required by DSI).
