Noise Source: John Larson, Executive Director of Team Ortho Foundation, has requested a sound level variance, at no requested sound level limit or specified distance from the sound source, in order to present announcements, speakers and music from 8:00 a.m. until 12:30 p.m., with a pre-event sound check at 7:45 a.m., on Saturday, October 27, 2018 on 2nd Street between Kellogg Mall Park and Jackson Street. The Department of Safety and Inspections recommends the following conditions: 1) Variance will be for announcements, speakers and music for the hours of 8:00 a.m. to 12:30 p.m., with a pre-event sound check at 7:45 a.m., on Saturday, October 27, 2018 for the Monster Dash 2nd Street between Kellogg Mall Park and Jackson Street location. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 80 dBA at 50 feet from the noise source. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:30 p.m. on Saturday, October 27, 2018.
