## **NOTICE OF PUBLIC HEARING**

Sound Level Variance – Shepard Road and 100ft South of Washington Team Ortho Foundation Monster Dash 2018

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance:**

**Location:** Shepard Road and 100ft South of Washington

Noise Source: John Larson, Executive Director of Team Ortho Foundation, has requested a sound level variance, at no requested sound level limit or specified distance from the sound source, in order to present announcements, speakers and music from 7:30 a.m. until 1:30 p.m., with a pre-event sound check at 7:15 a.m., on Saturday, October 27, 2018 at Shepard Road and 100ft South of Washington. The Department of Safety and Inspections recommends the following conditions: 1) Variance will be for announcements, speakers and music for the hours of 7:30 a.m. to 1:30 p.m., with a pre-event sound check at 7:15 a.m., on Saturday, October 27, 2018 for the Monster Dash Shepard Road and 100ft South of Washington location. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 80 dBA at 50 feet from the noise source. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:30 p.m. on Saturday, October 27, 2018.
