In cases of hardship, the owner may attend a legislative hearing to request the assessment be modified over several years. Please note; this is contingent upon the approval of the Legislative Hearing Officer. If you are the new owner of the property, you may still be responsible for any nuisance abatement charges incurred under the previous owner, if the assessments were not ratified by the City Council prior to you taking ownership.
