Fiscal Analysis

16 Amending the Parks and Recreation 2018 Capital Improvement Budget in the amount of \$1,516,810.79 to establish a multi-year project and budget for the design and construction of Pedro Park. This will allocate \$199,310.79 in Downtown Park Dedication Funds to the project; and also allocate \$1,317,500 of sales proceeds, contingent on the sale of the Public Safety Annex, from the HRA to the Pedro Park Project.

The remainder of this project funding will occcur in 2019, with an increase in CIB bonding of \$2,230,000 in 2019. Future CIB bonding issues will be decreased by \$1,115,000 each year in 2020 and 2021 to hold the city's annual debt service level.

Including future bond proceeds, the total project budget will be \$3,746,810.79.
