NOTICE OF INTENT TO SUSPEND LICENSE

RE: Recycling Collection Center license held by Vida Corporation d/b/a Vida Corporation for the premises located at 2327 Wycliff Street in Saint Paul License ID #: 20170001016

Dear Licensee:

The Department of Safety and Inspections will recommend suspension of the Recycling Collection Center license held by Vida Corporation d/b/a Vida Corporation for the premises located at 2327 Wycliff Street in Saint Paul. The recommendation is based on the following information:

On August 13, 2018, you were sent a letter and RENEWAL INVOICE from the Department of Safety and Inspection (DSI) stating your Recycling Collection Center license expired as of August 4, 2018 you now owed delinquent license and late fees. You were also required to submit the following information along with your license fee payment:

A completed Certificate of Compliance Minnesota Workers' Compensation Law Form

As of today, DSI has not received the delinquent license and late fee payment and the required Certificate of Compliance Minnesota Workers' Compensation Law form.

In addition to the suspension of your Recycling Collection Center license, per Saint Paul Legislative Code § 310.05 (m) (2), the licensing office will also recommend a \$500.00 matrix penalty for failure to submit required information to maintain your license.

You have four (4) options:

1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **Monday**, **October 15, 2018**, I will presume that you have chosen not to contest the proposed adverse action, and the matter will be placed on the **November 7, 2018** City Council Agenda for approval of the proposed remedy.

- 2. You can pay all delinquent fees and submit the required information listed above. <u>If this is your choice, you need to contact the Department of Safety and Inspections (651) 266-8989 to determine the total amount now due.</u> You may then send in the payments and information directly to DSI at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 by Monday, October 15, 2018. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent fees and submission of the required information will be considered a waiver of the hearing to which you are entitled.
- 3. If you wish to admit the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing by **Monday, October 15, 2018**. The matter will then be scheduled before the City Council to determine whether to suspend your Recycling Collection Center license and impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 4. If you no longer wish to do business in the City of Saint Paul, you will need to complete and return the attached REQUEST TO CANCEL LICENSE with the CITY OF SAINT PAUL to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 by Monday, October 15, 2018.

If you have not contacted me by Monday, October 15, 2018, I will assume that you do not contest the suspension of your Recycling Collection Center license and imposition of a \$500.00 matrix penalty. In that case, the matter will be placed on the November 7, 2018 City Council Consent Agenda for approval of the recommended penalty.
