My life experience has included both positive and negatives experiences with police officers. In comparison to millions of Americans, I have witnessed an alarming number of African-Americans killed by police officers and empathize deeply with the families who lost a love one to police use of force. That empathy motivated me to facilitate several trust building workshops between inner-city youth and law enforcement, called "Handcuffs to Handshakes". The workshops engaged many officers and youth who had a desire to move past their fears and build a relationship. My prior experience of making evidence-based decisions includes my involvement in Hennepin County JDAI executive steering committee. This committee's goal is to make recommendations with systems-involved stakeholders based on data. We desperate data and analyze the practices behind the research findings.
