CORRECTION NOTICE

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on November 08, 2018 and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

- 1. All vehicles must be correctly licensed, operable, secure from unauthorized entry, and parked on an improved surface. Correct violations; store in a garage or remove. FOUND VAN PARKED IN THE CURB CUT AREA WITH A FLAT DRIVERS SIDE FRONT TIRE. PLEASE AIR UP THE TIRE, REPLACE THE FLAT TIRE OR REMOVE THE INOPERABLE VEHICLE UNTIL THE TIRE CAN BE REPAIRED MAKING THE VEHICLE OPERABLE.
- 2. Sec. 157.03. Stopping or parking prohibited in certain places (2) In front of or within five (5) feet, of the throat of any public or private driveway or alley, or in such a manner as to block such driveway or alley. FOUND A CAR AND A VAN PARKED IN THE CURB CUT AREA OF THE PROPERTY ALONG OXFORD STREET NORTH. PLEASE REMOVE THE VEHICLES FROM THE CURB CUT AREA AS THEY OBSTRUCT ALLEY TRAFFIC FROM SEEING ON COMING TRAFFIC TRAVELING FROM NORTH TO SOUTH ALONG OXFORD STREET NORTH.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on **November 19, 2018**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**² and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.
