**Fiscal Analysis**

Amending 2018 ESG budget. Decrease of \$33,479 to reflect the total actual grant of \$566,521. Resolution is requesting approval to allocate funds from U.S. Department of Housing and Urban Development ("HUD")-Emergency Solutions Grant Program to 18 community agencies that assist Saint Paul citizens who are "homeless" or "at risk of becoming homeless." This is annual HUD allocation of Emergency Solutions Grant funds. Additionally, the Emergency Solutions Grant Program will have one vendor contract for data collection. No automatic renewal unless HUD appropriates the ESG Program. Total Budget is \$566,521 The allocation of federal Emergency Solutions Grant Program funds is recognized in the City's Consolidated Plan and related documents that are submitted to HUD. This Resolution also recognizes a budget adjustment to the Unspecified Contingency account, as appropriate.
