I've attached the case file and highlighted relevant portions. Nothing is implied I the meeting, minutes, letter or resolution about allowing occupancy of spaces in the basement lacking proper egress. I do not really have heartburn about the unpermitted installation of an egress window, per se (I would generally look for documentation on incorrect installation or an order to get a building permit) — especially because it was not in the orders. If they start using a part of the basement for sleeping which does not have proper egress, that becomes a problem and will need to be addressed.
