The Department of Safety and Inspections will be recommending the following conditions: 1) the Variance shall be for the hours of 8:00 a.m. to 1:00 p.m., with a pre-event sound check at 7:45 a.m., on Saturday, March 16, 2019 at CHS Field. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:00 p.m. on the date of the event.
