NOTICE OF PUBLIC HEARING

Shamrock's Irish Nook – St Patrick's Day 2019 Sound Level Variance

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Locations: 995 7th Street West

Noise Source: Michael Runyon, Shamrock's Irish Nook, has requested a sound level variance, at no specified sound level limit or distance, to present amplified music in an enclosed tent with use of a sound system for St. Patrick's Day Events on Saturday, March 16 and Sunday March 17, 2019 at 995 7th Street West. The variance is requested for the hours of 10:00 a.m. to midnight on Saturday, March 16, 2019 and from 10:00 a.m. until 11:00 p.m. on Sunday, March 17, 2019 with a pre-event sound check at 10:00 a.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 10:00 a.m. to 11:59 p.m. on Saturday, March 16, 2019 and from 10:00 a.m. until 10:00 p.m. on Sunday, March 17, 2019, with a pre-event sound check at 10:00 a.m. for the St. Patrick's Day Events. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources outside of the fully enclosed tent from 10:00 a.m. until 11:59 p.m. on March 16, 2019 and from 10:00 a.m. until 10:00 p.m. on March 17, 2019. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:59 p.m. on March 16, 2019 and no later than 10:00 p.m. on March 17, 2019.
