The variance is requested for the hours of 7:00 p.m. to 11:00 p.m., with a pre-event sound check at 6:00 p.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 7:00 p.m. until 11:00 p.m. on Friday, March 15 and Saturday, March 16, 2019, with a pre-event sound check at 6:00 p.m. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound sources outside of the fully enclosed tent. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:59 p.m. on Friday, March 15 and Saturday, March 16, 2019.
