This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. ## **Description of Variance:**

**Noise Source:** Macalester College, Athletic Field West of the Leonard Center Gym, 1600 Grand Avenue **Noise Source:** Macalester College, represented by Logan Schrader, Student Activities Coordinator, has requested a sound level variance in order to present outdoor music at the Athletic Field West of the Leonard Center Gym at 1600 Grand Avenue from 3:00 p.m. until 8:00 p.m., with a pre-event sound check from 11:00 a.m. until 3:00 p.m. on Saturday, April 13, 2019 for Springfest. The Department of Safety and Inspections recommends the following conditions: 1) The Variance shall be for the hours of 2:00 p.m. to 8:00 p.m., with a pre-event sound check from 11:00 a.m. until 2:00 p.m. on April 13, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound source. 3) The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:00 p.m. on the event date.
