We placed the BWC's in the center of our chests mounted to our uniform jackets and wear them as pieces of our uniforms. The BWC's were activated after receiving this call prior to arriving on scene and were active during the duration the investigation of this call. We did not review our BWC's recordings prior to writing this report, but may review the footage at a later time.

As people were leaving in vehicles, one female told us she is a Bamboo Hut employee who was supposed to have the night off but came in to work this last minute event.

Another female told us she was supposed to host this event at Azul, but hosted at the Bamboo Hut after the fire at Azul. I asked her what happened in the Bamboo Hut and she said the fight started in the VIP room. She told me she did not know who determined the VIP guest room list or bottle service. Neither female was identified because we did not know it was pertinent at the time.

Many performers said they were either on stage or backstage so they did not witness this assault occur We went to 1743 Iowa Ave. to speak with complainant LORRAINE DORIS HIASTH (DOB: 08/25/1958, 1743 IOWA AVE. 55106, C/P:651-776-1934). HIASTH said she was watching television in her living room when she heard 10-15 shots fired. When she looked out the window she saw people scattering from the Bamboo Hut at 1626 White Bear Ave. HIASTH believes that the Bamboo Hut is associated with drugs based on her experience when she went in there, but she did not elaborate further.

We then went back to 1626 White Bear Ave. to speak with bar patrons FUE XIONG (DOB:10/03/1988, 3223 49TH AVE. N.,55429, C/P: 612-396-2585) and BRIAN VILAYSONE (DOB: 06/01/1987, 1877 TODD DRIVE, 55117, C/P:651-315-1379).

XIONG reported hearing a commotion, going outside and seeing police.

VILAYSONE reported that crew members of one of the groups that was performing getting assaulted by approximately four to six people. VILAYSONE does not know the name of the crew member, but that they are part of a group called "MWM" which stands for Midwest MONSTERS. VILAYSONE said Midwest Monsters is a "Crip Crew". VILAYSONE reported that the leader of the Midwest Monsters is a man that he knows as "MITS". VILAYSONE reported MITS was at the Bamboo Hut and when he learned of the assault, he ran. VILAYSONE reported that the Midwest Monsters have a lot of rivals and was unable to list any of them. VILAYSONE also reported that the original venue was supposed to take place at Azul night club in Minneapolis, but the venue changed to the Bamboo Hut at the last minute because at 1900 hours there was a fire at Azul.

We were unable to determine if the Bamboo Hut pulled a permit with the City for this event.

Other officers who were in the Bamboo Hut told us there were cold alcoholic beverages inside.

On 02/24/2018 at 0033 minutes, police responded to the Bamboo Hut located at 1626 White Bear Ave. on reports of shots fired. As law enforcement officers from three separate agencies arrived on scene, approximately 400 people were attempting to leave either on foot or in vehicles. Speaking with performers, patrons and employees who were leaving the Bamboo Hut parking lot, officers determined that this last minute birthday celebration event included multiple performers on stages, VIP rooms and bottle services. Officers located a male at a nearby business who ran after being shot twice at the Bamboo Hut. No arrests were made at that time.

All three parties stated they were inside of the bamboo hut when a large fight happened. The fight carried outside and they did not see or hear anything past that. I asked if they know who fired a gun and they all replied "we didn't know anyone had a gun". I advised them that a male was shot and they all said they were inside and there was too many people to hear anything.

On 02/24/2018 at approximately 0033 hrs, I, Officer Leopold (Sqd. 366) responded to 1626 White Bear Avenue (Bamboo Hut) on a report of shots fired, with a possible male victim. Upon arrival, there were several people and vehicles in the parking lot near the Bamboo Hut. I entered the address in attempt to speak with any witnesses inside.

I first spoke with, Vameng Tiny XIONG (DOB: 02/22/1994, 32 Geranium Ave E St. Paul, MN (C) 651-313-4537. XIONG stated he is related to one of the owners who he said was TENG. XIONG advised he arrived to the Bamboo Hut at approximately 2330 hrs. XIONG said a fight was occurring in the concert/banquet hall and it spilled out into the bar area. XIONG stated it appeared one male was being assaulted by several other individuals. XIONG advised the male being assaulted was wearing a white T-shirt with a sweater over the top of it.

XIONG advised the individuals were pushing the male, hitting him with a chair and beer bottles. XIONG stated it

was chaos and there were a lot of people so it was hard to see who the aggressor was or to get further descriptions. XIONG stated a black male jumped into the fight to help the male being assaulted. XIONG said the fight eventually ended up outside and he did not know what happened once it did so.

XIONG was with a female, Crystal Douchi XIONG (DOB: 01/23/99, 850 Beech St St. Paul, MN (C) 612-987-0149. C. XIONG gave a similar story and did not provide any further details.

I briefly spoke with a manager on scene who was identified by MN ID as, Teng LY (DOB: 12/21/1978, 1157 Ferndale St. N Maplewood, MN (C) 715-288-7129. LY stated he spoke with a frequent customer earlier in the day (1851 hrs) who was wanting to use some space at the Bamboo Hut. LY stated he was Facebook messaging with the male who he said was, Mit VONGSOUVANE. VONGSOUVANE contacted LY asking if he could put something together because the club got shut down. LY agreed and said VONGSOUVANE showed up to the address at approximately 2130 hrs. LY stated he did not anticipate it turning into what it did tonight.

I asked LY about camera footage, which he had access to. LY stated the system was not functioning properly so he was not able to pull up the correct time frame of when the assault occurred. LY also stated during the conversation that he is not licensed after 0030 hours.

I later looked up VONGSOUVANE on DVS and he is believed to be, Mithsavane VONGSOUVANE (DOB: 02/24/78, 17280 72nd Ave N. Maple Grove, MN (C) Unk). Officers on scene gathered information that VONGSOUVANE was having a birthday party.

We cleared the Bamboo Hut to look for additional victims, none were located.

I identified a female inside as VUE, MAI HOUA (DOB 03/27/88, 1367 SHERBURNE AVE, 651-424-6633). She stated the argument started back in the party room. Males were smashing beer bottles over each others head. The fight spilled outside and she does not know what happened after that. She did not recognize any people involved. She went and hid in the bathroom until police arrived.

I identified multiple parties standing outside the Bamboo Hut who were inside when the fight broke out. The individuals were identified as LY, VANG (DOB 09/1995, 1858 MAGNOLIA AVE, 651-248-9182), KONG, MENG HANG (DOB 08/13/91, 1495 PALOMINO TRAIL EAGAN 55122, 517-574-3019), HANG, KOU KEVIN (DOB 04/13/96, 1495 PALOMINO TRAIL EAGAN 55122, 651-231-2224), YANG, COOLCY (DOB 02/03/93, 1640 E 7TH ST 55106, 651-424-3456), VANG, WESLEY DAMIEN (DOB 02/14/95, 1508 CASE AVE, 651-246-2070), HANG, CHANNE (414-544-4509, 7934 W DENVER AVE MILWAUKEE WI), and KHANG, GAO IB (DOB 08/03/96, 1608 PARK ST 55117, 651-352-5539).

He alerted to the recent human odor emanating from the cap. The cap was turned over to a district squad. He searched through the deep snow and did not locate any additional evidence.

All of KIM's clothing was collected as evidence and turned into the SPPD Property Room. We interviewed KIM and initially stated that he was in too much pain to speak with us. Eventually KIM stated that he was running away from a fight that occurred inside the bar. KIM also did not know who had shot him. KIM also confirmed that he was in town from Chicago. KIM was unable to provide us with any further information.

Officer Dollansky took photographs of KIM. See his supplement report for further.

My BWC was on and active during my entire investigation. It was turned off while in the emergency room lobby, but was reactivated when I entered KIM's hospital room to speak with him. I did not review the footage prior to writing this report.

On Saturday 02/24/2018 at 0033 hrs we, Sqd 329 (Dollansky/Frederickson), responded to 1626 White Bear Ave N (Bamboo Hut) to assist Sqd 324T (Obrestad/Mancheski) on a shots fired call. Call comments stated a victim that was shot was across the street from Bamboo Hut in a snow bank.

My BWC was activated prior to and during all investigative aspects of the incident. I turned my BWC off after dropping Ofc Frederickson off at Regions Hospital to go to East Team to get a camera. I turned my BWC back on record while taking photos of the victim (KIM) and while interviewing him. I did not review the video for this report.

Upon arrival, Sqd 326 (Wiebusch) radioed that he located the victim, later identified as SAM V KIM (07/18/87), behind the carwash at 1635 White Bear Ave N. We went to that location to assist and found KIM lying in a snow bank behind the address next to a fence. It appeared he had a gunshot wound to his left arm just above his armpit and a gunshot wound to his right calve. KIM was conscious and breathing. KIM stated he was inside Bamboo Hut when a fight broke out and then gunshots. KIM said he was running across the street to get away from the gunshots when he was shot.

SPFD Medics arrived and transported KIM to Regions Hospital.

Ofc Frederickson spoke to KIM'S friend LIM who she had in the back of our squad. See her supplement for further details.

We transported LIM to Regions Hospital. I dropped off Ofc Frederickson at Regions and went to East Team to get a camera.

I returned to Regions Hospital and took the following photos of KIM:

On 02/24/2018 and at 0033 hours I (Off. Wiebusch SQD #326) assisted other squads at 1626 White Bear Avenue for a report of shots fired. As I arrived in the area it was aired that a victim was across the street from scene.

I went to 1635 White Bear and saw an Asian male (LIM) walking in front of the Boler Car Wash. I made contact MODINA LIM who stated his friend was shot and was laying behind the address. I notified dispatch and drove to the rear of 1635 White Bear. When I got to the rear LIM told me his friend was resting between a snow bank and a fence. I shined my flashlight towards the area were LIM pointed and saw SAM KIM laying in the snow. I made my way over to KIM and asked him where he had been shot. KIM said he had been shot in the left and right leg. I gently removed KIM's jacket and his hooded sweatshirt. When I did this I found there was blood on KIM's white tee shirt over his left arm and shoulder. I used my pocket knife to cut a hole in the shirt to assess his wound. I found what appeared to be a gunshot wound on KIM's left arm just below his armpit. We then lifted up KIM's right pant leg and found a large wound on his right calf. I asked KIM if he saw who shot him but he told me he had no idea. I also asked if he was the intended target but he stated he didn't know. Medics arrived and transported him to Regions.

I left the car wash and went to assist other squads at the scene who stated they need assistance with conducting a safety sweep of the building. After the sweep came up clear, I assisted K9 Off. Vetsch with an article search along the North side of 1635 White Bear and the rear of 1635 White Bear along with the rear 1645 White Bear (Dry Cleaners). During the article search we located a camouflage ball cap with a Chicago Bulls logo on the front. The ball cap was located just north from where KIM was found. Squad #322 (Off. Gelbman) held the scene while I went back to 1626 White Bear.

With the help of Ramsey County Deputies and Maplewood officers, we located what appeared to be .45 caliber spent casings and one 5.7mm spent casing. We located the first set of .45 cal casings in the middle of a parking near a silver vehicle, another set of casings were found on the west side of the parking lot where the parking lot boarders the sidewalk on White Bear. It should be noted the 5.7 spent casing was located near the rear passenger side of a white vehicle which was parked on the west side of the parking lot near the side walk. The third set of casings were found just to the north of the second set on the other side of a red sedan. The casing were photographed and collected by myself and squad #371 (Off. Moody). We also photographed and collected a blue ball cap which was found just next to the front door of 1626 White Bear. After photographing where we located KIM and the camouflage ball cap, squad #371 and myself walked around the north side of 1643 White Bear and located a surveillance camera on the north side and east side of the building. Off. Moody notified me that he had located what appeared two spent rounds (Bullets) on the sidewalk along the west side of white bear and in front of 1643 White Bear. The spent rounds were photographed and collected by Off. Moody and myself.

All the items recovered from the scene were packaged and placed in the SPPD Property Room.

I, Ofc. Moody, am issued and equipped with a Body Worn Camera (BWC) and trained in its use. I place the BWC in the center of my chest mounted to my uniform shirt or jacket and wear it as a piece of my uniform. The BWC was activated after receiving this call prior to arriving on scene and was active during the duration of the investigation of this call.

I did not review my BWC recording prior to writing this report, but may review the footage at a later time.

Upon arrival, I positioned my squad to block the southeast entrance of the lot. As I exited my squad, other squads updated the victim may be behind the Boler Car Wash - 1635 White Bear Ave. I ran to that location and assisted Ofc. Wiebusch and Ofc. Dollansky in locating the victim. We located the victim hiding behind a large snow drift next to the fence at the extreme northwest end of the property. We found the victim had been shot twice in the shoulder and leg. I updated that medics were cleared in and the victim had been shot. There was also another male with the victim at this location, both were identified by other officers.

When medics arrived, Ofc. Wiebusch and Ofc. Dollansky remained to assist medics. I returned to the scene to assist. We first cleared the interior of the restaurant to ensure there was no additional victims or suspects inside. Employees of the store were already attempting the clean the restaurant and I directed them to immediately stop what they were doing to attempt to maintain the integrity of any evidence inside. We located a large party room at the south end of the restaurant that the fight initially began in. The room had a large amount of alcohol inside spread throughout the room. We located no other victims or suspects.

I then returned outside to assist in attempting to locate any physical evidence outside. Other officers located multiple shell casings in the parking lot, which were marked for photographing and later collection.

I also identified two parties outside who were in the bar at the time of the incident. SAROUM HENG (DOB 09/13/1982, 112 Geranium Ave E, 651-502-3039) stated he did not see or hear anything during the incident. KHINO XIONG (DOB 08/17/1996, 1061 Desoto St, 651-202-1584) stated he was part of the entertainment for the party. He stated the party was a birthday party for a person he knew only as "MIT." He stated there were multiple acts from around the country that were present and stated the entertainment acts were affiliated with the Crip street gang. He denied seeing any of the altercation or the shots being fired, stating he was inside during the incident. He had nothing further to add.

At this point, I began photographing the scene and any physical evidence located. I took the following photos of the scene:

After photographing each spent casings, Ofc. Wiebusch collected the casings. See his report and property report for further.

After photographing the location the victim was located, we searched the surrounding area for additional physical evidence. On the sidewalk on the west side of White Bear Ave directly in front of 1645 White Bear Ave - The Laundry Room, I located two spent rounds (bullets). These were also photographed and collected. I also located several fresh tracks in the snow directly to the west of where the spent rounds were located through the deep snowbank. Based upon their location and direction of travel, I believed these tracks to belong to the victim. Based upon their direction of travel, I believe the victim traveled alongside the north side of the Laundry Room before ending where we had located him. There appeared to be surveillance cameras on the exterior of the Laundry Room which may have captured this on film. We were unable to check with the business due to the time of the call.

We continued to search the area for additional physical evidence, but were unable to locate any further. It should be noted that dispatch notes advised one caller reported the victim may have also had a firearm, but we were unable to locate any of the firearms used in this incident.

We then cleared the scene.

While writing this report, Ofc. Fields alerted me she located a video of the incident in the bar posted on Facebook. The video was posted on the Facebook page of KEVIN YANG (Unknown DOB, Phone, Address). The web address of the Facebook page was http://www.facebook.com/Yangkevin29. The direct web address for the video was https://www.facebook.com/Yangkevin29/videos/1691591010906150/.

I was unable to save the video from the web page and attempted to record the video using my BWC. That video is available from my BWC footage.

The video shows a large number of Asian males assaulting several others, including two African American males, in the restaurant area of the bar. The aggressors were using chairs and beer bottles to assault the

others, along with using their fists and feet. One of the African American males, wearing white pants with a red stripe and blue accent on the bottom, white t-shirt and white baseball cap, was still on scene when officers arrived and was likely identified by other officers. The other African American male had long dreadlocks and was wearing a white long sleeve shirt and gray jeans. This male appeared to be the primary victim of the assault. He was forced to the ground and was struck with a chair and punched and kicked while on the ground. Several others came to his aid and they attempted to flee the restaurant. They were pursued by two Asian males. The first is an Asian male, in his late 20s to early thirties, approximately 5'6" - 5'8", average build, with short black hair, wearing black jeans and a black hooded sweatshirt with white writing on both sides of the chest and on the right shoulder. The second is an Asian male, of similar age, slightly shorter, average build, with close cropped black hair, wearing black pants, a black hooded sweatshirt with a white Air Jordan symbol in the center of the chest and a white jacket. The second male can be seen reaching into the right side of his waistband and removing a firearm as both pursue the other group out of the restaurant. The shooting victim and the other male with him can also be seen in the video attempting to come to the aid of the second African American male.

On 02/24/2018 at approximately 0033 hours squad 312 (DeJong) responded to the Bamboo Hut at 1626 White Bear Ave to assist squad 324T (Mancheski/ Oberstad) with a report of an aggravated assault. Prior to my arrival officers were informed that shots had been fired in the area.

Upon arrival I assist responding officers in clearing the building. While searching the building officers I observed a woman cleaning the dinning room area. I observed multiple blood drops in the entry way near the cash register. While walking through the restaurant I observed broken glass and food on the ground.

Once officers cleared the main restaurant we were informed that there was a back party room where customers had been during the night. I asked the manager if her could unlock and open the party room door. When the manager opened the door I observed that the light were off and the room was completely dark.

As we searched the room I observed multiple open containers in the party room with alcoholic beverages. When I touched the containers a few were cold to the touch and some still had un-melted ice inside them. I also observed broken glass bottles on the floor and a stage set up with sound equipment. Officers cleared the party room with negative results.

Once the scene was safe I spoke to individuals that were still inside the restaurant. I spoke with Ka VUE (11/20/1982, 658 Hyacinth Ave, 612-987-0099), Elizabeth YANG (12/09/1988, 422 W. Minnehaha Ave, 651-717-8122), Pao Nja YANG (03/06/1991, 1589 Iowa Ave, 612-469-0817), Scott Fue YANG (02/03/1991, 1589 Iowa Ave, 763-204-3322), Xiong KHANG (08/05/1982, 422 W. Minnehaha Ave, 763-443-3196) and Husky HANG (06/17/1983, 658 Hyacinth Ave, 651-353-4391) who stated the following about the incident:

VUE and her friends were all the restaurant to eat dinner at approximately 2030 hours. The group was sitting towards the back of the dinning room near the bar when they hear a commotion coming from the back of the restaurant. The group stated that they say a large group of males, approximately 10-15 people, physically fighting with each other. The fight led to the front of the restaurant and eventually continued out the front door.

A few minutes late a few people walked back inside and the group over heard some one say that someone was shooting outside. They then saw a large group of people walk back into the restaurant. No one from the group was able to determine who started the fight or what it was about.

When I asked the group if they saw anyone shooting or see anyone holding a gun the group stated that they did not even hear the shots from outside or see anyone with a gun.

I then spoke with Lucie LY (05/19/1989, 1171 Geranium Ave, 651-500-7664) and Lina Thao (02/09/1994, 2229 Ryan Ct, North St Paul, 651-968-9689) who stated the following about the incident:

LY and Thao are friends of the owner and manager at the Bamboo Hut. The two come to the restaurant to eat at approximately 2100 hours. After eating the staff asked the two to stay and help out as it is a family run restaurant.

While the two were helping near the bar they observed a fight break out near the bar. They hid behind the bar as the fight continued through the restaurant and out the door. Neither LY or THAO knew who stated the fight of what it was about. When they were asked about the gun shots, neither were able to provide any suspect information as they were trying to stay out of the fight.

After speaking with staff I was asked to step out front tow speak with LY who had more information. LY informed me she noticed an Asian male at the bar with tattoos on his neck and above his right eyebrow. LY remembered him because there was a video playing on the TV's in the restaurant with him in it. LY did not want to say anything inside the restaurant in front of the staff and her friends.

After peaking with LY I went back inside the restaurant to speak with the staff on scene. I spoke with
Blia VANG (07/15/1988, 1315 Desoto St. #1, 612-206-6359), and See YANG (05/19/1982, 1271
Gresham Ave Oakdale, 651-242-8812) Who stated the following about the incident:

The staff on scene stated the manager agreed to let a locally known group known as the "Mid West Monsta's" have a party in the back room. The group was supposed to have the party at a venue down town but had to change because the venue burned down.

The party was for an Asian male known as "Big Monsta" who was celebrating his 40th birthday. They described "Big Monsta" as an Asian male approximately 5'1-5'3 in height, stocky build with tattoo's on his neck. Staff could not remember what he was wearing tonight or what his involvement in the fight was. During the shooting the staff stayed in the restaurant and did not have any suspect information at this time.

I then spoke with Yeng-Kong LEE (05/04/1966, 5800 East River Rd. Fridley, 507-581-4763) who was working security during the incident. LEE stated the following:

LEE was working up front when he saw the fight taking place at the back of the restaurant. LEE attempted to guide people out as the moved to the front door. LEE stated the front door was locked at 0030 hours. Anyone who walked out of the restaurant was not allowed back inside.

Approximately 20 minutes after the fight led outside LEE heard one shot that sounded further away followed by two more shots. LEE was unable to provide any suspect information as his attention was focused inside the restaurant.

The manager was able to pull up video n his cell phone and showed me the footage. The footage showed the fight at the bar and was in black and white. I was not able to make out specific suspect information from viewing the footage on the cell phone.

I gave the manager a business card with the case number and advised him to make a copy of all the footage from the night and call officers when the copy is ready to be picked up. Squad 366 (Leopold) spoke with the manager about the incident. See squad 366's supplement report for full details.

LY had no new information regarding the fight or the shooting that took place outside.

While speaking to LY, he informed us he made a copy of the fight. LY downloaded the videos into a flash drive, which was turned over to us. We thanked LY for his time and cleared the scene.

It should be noted, we were unable to transfer the files into the Media Vault since the files were created under a special program. We viewed the video and observed a large fight in the middle of the restaurant. It appeared a large group was physically assaulting several people. Chairs and bottles were used to assault the victim. Eventually the victims regained their composure and were able to exit via the main door. The group then disappeared outside of camera view. We were unable to identify anyone involved in the fight at this time.

He was wearing a green army fatigue hat with a tan or yellow bill. This description was consistent with Squad 329's (Dollansky/Frederickson) description of the victim's clothing when he was located behind 1635 White Bear Ave.

Cam 5 at 01:32:23 hours:

Before the fight started, the victim was observed standing in the bar area. After the fight started, the victim can be seen standing to the side. As the fight moved from the bar area to the main dining area, the victim can be seen interacting with another Asian male. This male was wearing a white long sleeve jacket with a black hooded sweater. The black hooded sweater shirt has a white Michael Jordan logo on the front. He was wearing black jean pants and a two tone black and white Jordan shoes.

Cam 1 at 1:32:46 hours:

As the victims were moving towards the door, the suspect can be seen (with another unidentified male dressed in dark clothing) following the victims outside the door. As the suspect was moving towards the victims, he was seen reaching for his waistband with his right hand as if he was reaching for a gun. Due to the camera angle and distance away from the suspect, I was unable to see a gun.
