BWC available, not reviewed - Officer SLATER, Officer SACHI and Officer FREDRICKSON. No ICC.

On 3/29/18 at 0030 hrs, we (Officer SLATER & Officer SACHI - 329T) along with Officer FREDRICKSON (311) did a proactive police visit at 1626 White Bear Ave (Bamboo Hut) to verify if the business was in compliance with city ordinance.

I observed a unknown male exit the business at 0030 hrs than walk back inside once he saw the marked squad cars. Shortly after, TENG LY (DOB: 12/21/1978, 1157 Ferndale St, Maplewood, MN 55109, 715\*288-7129) exited the business and came to speak with us at the squad cars. LY later stated he was the manager tonight and was bartending. I advised LY why officers were there and told him that we would be walking into the business.

While standing outside waiting for LY to let us in, I could see multiple people sitting/standing around the bar in clothing that did not make me think they were employee's. I saw at least one male drinking a beer while standing outside looking through the window.

Once we were let in, we observed at least 8 people walking away from the bar and leaving the business. LY stated these individuals were family. We did not identify the customers as they were trying to leave when we entered.

Another employee I identified was MAY LEE (DOB: 5/10/59, 1567 Myrtle St, Maplewood, MN 55119, 651-246-3160).
