NARRATIVE

BWC available, not reviewed - Officer SLATER, Officer SACHI and Officer FREDRICKSON. No ICC.

On 4/7/18 at approximately 0030 hrs, we (Officer Slater & Officer SACHI - 329T) along with Officer FREDRICKSON (squad 311) were at 1626 White Bear Ave (Bamboo Hut) doing a proactive police visit to ensure all customers were out of the business no later than 0030 hrs. Officers were in marked police vehicles and full duty uniform.

At approximately 0033 hrs, we went to the front doors of the business which we found to be locked. Looking in, it appeared there were multiple people inside the business that were dressed in casual street clothing and not clothing that gave me the impression they were employees of the business.

We observed an older male who I later identified as CHONG GE CHA (DOB: 10/15/47, 3040 Ardmore Ave, Mounds View, MN 55112, C/P: 612-207-7534) come to the front doors and tell us the business was closed. I observed CHA to be wearing an older military winter camouflage jacket that was not zippered close. I observed what looked like a police outer carrier soft armor vest with some type of star badge on the left chest of the outer carrier. It also appeared as if CHA was wearing a police duty belt and had a baton on the belt. CHA went back into the business without opening the doors for us.

I observed TENG LY (DOB: 12/21/78, 1157 Ferndale St N, Maplewood, MN 55119, C/P: 715-288-7129) who I know from previous contacts to be the manager of the business, escorting 5 individuals out of the business. I observed CHA assisting LY escort these individuals out. The individuals escorted out were in regular street clothing that did not make it appear they were employees.

We spoke with LY and advised him we were at the business to document if all customers were out of the business prior to 0030 hrs. While speaking with LY, he stated multiple times he was sorry and admitted that the individuals who he just escorted out were customers. While speaking with LY, a female came out from the kitchen area and LY indicated that she too was a customer saying her ride was waiting for her out front. LY stated CHA was a volunteer security guard for the business.

Nothing Further.

PUBLIC NARRATIVE

SPPD squads completed a proactive police visit at 1626 White Bear Ave (Bamboo Hut) to ensure business was compliant with requirements to have all customers out of the business no later than 0030 hrs. Officers observed 6 customers, some of which appeared heavily intoxicated exit the business after 0030 hrs. Officer observed a male dressed as a security guard come to the front locked doors but not open the door for us, saying they were closed. Officers observed the security guard than go back inside the business. The manager advised there was a bridal shower in the restaurant tonight.
