NOTICE OF CONDEMNATION UNFIT FOR HUMAN HABITATION **ORDER TO VACATE**

Dear Property Representative:

Your building was inspected on February 15, 2019. The building was found to be unsafe, unfit for human habitation, a public nuisance, a hazard to the public welfare or otherwise dangerous to human life. A Condemnation Placard has been posted on the building. The following deficiency list must be completed or the building vacated by the re-inspection date.

A reinspection will be made on March 12, 2019 at 2:15 PM.

CONDEMNATION OF THE BUILDING REVOKES THE CERTIFICATE OF OCCUPANCY.

Failure to complete the corrections may result in a criminal citation. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy.

DEFICIENCY LIST

- Exterior Front Guardrail SPLC 34.09 (3), 34.33(2) Repair or replace the damaged 1. guardrail in an approved manner. This work may require a permit(s). Call DSI at (651) 266-8989.
- Interior Basement MSFC 603.7 Immediately discontinue use of unsafe heating 2. appliance until repaired or replaced by a licensed contractor. This work may require a permit(s). Call DSI at (651) 266-8989. Red tags may not be removed except by fire department inspector. -The boiler is not working. Provide or repair the boiler.

- 3. Interior Basement Stairs SPLC 34.10 (3), 34.34(2) Repair or replace the unsafe stairway in an approved manner. -There is a stair tread that is not the correct size. Provide the correct stair tread.
- 4. Interior Kitchen Sink SPLC 34.11 (1), MSBC 2902.1, SPLC 34.35 (1), MPC 301.1 Repair or replace and maintain all parts of the plumbing system to an operational condition. -Repair or replace and maintain an approved kitchen sink. This work may require a permit(s). Call LIEP at (651) 266-9090. Provide an aerator for the kitchen sink and the water pressure is low.
- 5. Interior Throughout SPLC 34.23, MSFC 110.1 This occupancy is condemned as unfit for human habitation. **This occupancy must not be used until reinspected and approved by this office**. -This property has been condemned because the boiler has been red tag by Xcel Energy and there is currently no heat in the house.
- 6. Interior Throughout SPLC 34.19 Provide access to the inspector to all areas of the building.
- 7. Interior Throughout SPLC 34.11 (6) Provide and maintain a minimum of 68 degrees F in all habitable rooms always.
- 8. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.

You have the right to appeal these orders to the Legislative Hearing Officer.
