RE: Local Historic Designation of Saint Andrew's Church

Dear Mr. Justin.

It is with great pleasure that we, members of Save Historic St. Andrew's (SHSA), write in support of a determination of eligibility of the former Saint Andrew's Church as a St. Paul Heritage Preservation Site. We share in our Capital City's respect for history and recognition that authentic reflections of our past are a vital part of today's healthy communities. We are grateful that City policies prioritize historic preservation and encourage active citizen participation. SHSA would like to thank the staff of the Heritage Preservation Commission for their guidance in pursuing the protection of an historic landmark in our community.

We recognize that SHSA is seeking historic designation without the cooperation of the building's owner, the Twin Cities German Immersion School (TCGIS) Building Company. However, throughout this process it has been our sincere hope that TCGIS would welcome other community perspectives and expertise to the table to genuinely explore alternative options to full demolition of the building. To this end, we have been diligently working with local experts in adaptive reuse to organize a design charrette, where viable alternatives can be developed that incorporate both the needs of the school and concerns of the broader community. If the former St. Andrew's church, now the Aula of TCGIS, is determined to be eligible for historic designation, we anticipate that it may be the needed catalyst for working together towards a collaborative solution.

Our efforts towards historic designation began when we learned that TCGIS intended to demolish and replace the Aula/St. Andrew's as a part of the school's expansion plan. As a true grassroots effort that started with a handful of neighbors just seven months ago, all our accomplishments represent the hard work of dedicated citizens operating without the advantages of an organized institution. Regarding our efforts, we would like to highlight the following:

#### 1) Substantial neighborhood and public support for historic preservation of St. Andrew's

- Over 600 people the majority being Como neighborhood residents signed our initial petition, asking for TCGIS to delay building plans to allow for a historical assessment of the property and broader community input.
- We have raised \$8,530 from 89 people via a GoFundMe campaign.
- 140 "Save Historic St. Andrew's" lawn signs are on display, most by homeowners in the Como neighborhood.
- Over 80 people attended our public forum on October 11th, 2018.

#### 2) Broad and supportive press coverage

#### 3) The independence of the historic preservation consultants

We would like to emphasize the distinct independence maintained by the historic preservation consultant team hired by SHSA to prepare the historic nomination of St. Andrew's. From the very first steps, Rolf Anderson clearly prioritized, through direct communication and by his actions, the need for unquestionable objectivity in his work. In the process of selecting a professional to lead this work, this was a key factor in our decision. Although members of SHSA helped to locate archived documents, the interpretation of the historical information was made by the consultant team alone. In fact, many members of SHSA never met Rolf Anderson or other members of the team until our forum on October 11<sup>th</sup>, after the completion of the nomination document.

Given the strength of the nomination, we urge the Commission to vote in favor of designating the former St. Andrew's Church eligible as a St. Paul Heritage Preservation Site. We believe the facts speak for themselves.

I am not a neighbor of the former St. Andrew's Church, and I am not a former parishioner. I am a concerned resident of St. Paul that appreciates the history and architecture of the former St. Andrew's Church at 1031 Como Ave.

The architecture is unique. They call it Romanesque Revival, but it is actually a combination of several early styles. The brick work is custom and artistic. The brick work varies greatly on different sections of the building. And the multi-colored tile roof is amazingly beautiful. I have not noticed another roof like that any where else in St. Paul.

The architect was Charles A. Hausler. Mr. Hausler was highly respected for the quality of his work. And Mr. Hausler was quite progressive for his day, often hiring women and minorities to help with the drafting work. Mr. Hausler went on to represent St. Paul ward 5 and 6 in the Minnesota Senate. There he fought to improve building and safety codes.

So for the reasons stated above, I ask you to help the Como/ Warendale community to save St. Andrews. Six other Hausler designed buildings already have historical designation. But none of those six are as unique and beautiful as historic St. Andrew's.

Dear Mr. Gause:

My family has been in the Como Park neighborhood since approximately 1900. It was around that time that my paternal great grandparents, Coleman and Justina Horvath, emigrated from Hungary to St. Paul, Minnesota and settled in Como Park. Since 1903 my family had been parishioners of St. Andrew Church. Also, Coleman Horvath, like many Hungarians who settled in the Warrendale neighborhood, monthly contributed money to the building of the new St. Andrew Church building on Como Avenue.

Coleman and Justina were married in 1908 in the first St. Andrew Church, which was located near Argyle and Hatch in St. Paul. They celebrated their 50<sup>th</sup> wedding anniversary at the St. Andrew Church on Como Avenue. All six of their children attended St. Andrew's School; their oldest child, Gizella, my paternal grandmother, was in the first, First Communion Celebration at St. Andrew Church. Gizella's children, John Gubasta, Jr. (my father) and his sister Dolores Gubasta attended St. Andrew's Catholic School. My siblings and I were the fourth

generation to attend the school and my nephew, Evan, was the fifth generation to do so.

There are several hundred other family stories that are similar to mine. Families of German, French, Hungarian, Italian, Russian, Greek, and Spanish heritage (to name a few) who fused their spiritual and social lives in Church of St. Andrew and its school. Even though many of those preceding generations have moved on, it does not mean St. Andrew Church building no longer has historic and cultural value. To raze St. Andrew Church building is to destroy the rich, historic and cultural identity of this beautiful neighborhood in Como Park.

Charles A. Hausler, St. Paul's first city architect in 1914, designed the St. Andrew Church building. It represents a distinctive example of the Romanesque Revival Style, which was inspired by Romanesque churches built in southern France and northern Italy. For newly arrived immigrants to the United States, like my paternal great grandparents, St. Andrew Church building represented the courage and the strength of the human spirit to endure great hardships to reach the shores of their new country, struggling to win acceptance in the New World while retaining the unique habits, customs, and beliefs that today contribute to our shared identity.

On behalf of the Gubasta and Horvath families, I strongly implore St. Paul's Historic Preservation Commission to designate St. Andrew Church building a local heritage preservation site.

I understand the conundrum of what to do about this unique church building. It is a beautiful structure aesthetically. As a church worker and member, I also understand the great sentimental value that the church has to people both historically and spiritually.

As someone who is invested in the school, I also understand the challenges of the current church building for our purposes. I have attended many performances and activities in the Aula space. I can tell you that the acoustics in that room are horrible. Sound echoes

off the walls making even an amplified voice hard to understand.

Audience seating for performances is metal folding chairs. As a gymnasium it is also substandard. There are stairs and uneven spaces for children and balls to run into. And there is no space for bleachers so we are unable to host any sporting events in our space. It it is not an ideal space for either a gymnasium or auditorium.

I honestly do not know the solution to the issue we are facing about this space. But I do have some thoughts that I wish to share as you weigh the issues. I can appreciate the beauty and history of a significant structure, but historical places are either refurbished and sustained by actual tours of the building itself, or they are re-purposed for some practical reason. I do not see the church building becoming a historical destination in its own right. If that were the case, it would have been purchased and restored years ago.

It HAS been reorganized into a practical space since the German school moved into the property. But now, understanding the costs involved in maintenance and updates it is no longer practical for us. Frankly, it would be irresponsible for the school to invest large sums of money into this space, especially as it is not an ideal facility for us.

Honestly, I am not opposed to moving our school elsewhere in search of better accommodations, though I do have friends who feel strongly about staying in this neighborhood. We are ideally located within walking distance of wonderful natural areas. Como Park has been an excellent way for us to make up for the lack of open yard space on our campus. Parking during busy times is also an issue for parents, but we are organized and try to be respectful of the neighborhood.

So if we DID find another suitable facility and decided to move, how difficult would it be to sell this property? With the neighborhood controversy and hostility be enough to deter potential buyers? Would the lack of expansion space available and other factors I mentioned make the property unappealing to new buyers? TCGIS cannot absorb the costs needed for long term maintenance and restoration of the church building. Does the community prefer to have a vacant, lifeless building at its center?

These are a few of my thoughts and concerns surrounding the Historical designation of the former, St. Andrews church. I do not envy the decision you will have to make, but I think your impartial leadership will be very helpful to this disaggreement - so I thank you for your moderation!

I am a Como Park resident with no ties to TCGIS, other than to appreciate that we have an extremely successful public school in our neighborhood. I wish to keep the school where it is, and give future children the opportunity to experience language immersion education. I ask that you reject the nomination of the former church building for historic preservation.

The neighborhood would be much better suited by having an active school in a building that meets their needs, as opposed to a deteriorating building or, at worst case, a vacant property. The objectives of a small number of neighbors that can directly see the building out of their front windows should not take priority over the thousands of people who have and will continue to receive a benefit from the school.

Dear HPC Chair,

I have lived across the alley from the St. Andrew's site for forty-two years. We were members of the parish community. My children went to school there and I worked for the parish as a volunteer and in a paid position for several years. There are many good memories of time spent there. Long term friendships were formed there. It was a sad day when the Archdiocese no longer saw it as a viable parish. The Archdiocese abandoned and sold it with little concern for its future. The new owners of the property made no commitment to preserving the buildings as they were at time of purchase.

I thought the HPC had a guideline that a building must be at least one hundred years old to qualify for HP. This building does not qualify. I thought another guideline was that the building owner must be seeking the HP status. The owners are not seeking this status. If these guidelines are true, I'm not sure why any of this is being discussed. I also heard (true or not) that HPC is not concerned about alterations to the interior of the building of which there have been many over the years. The exterior was altered by attaching the school building to the church building. In order to preserve the church building with integrity will HP require the attachment be taking down?

The Twin Cities German Immersion School has grown and is seeking to alter *their* property again On the flip side there are some well intentioned people seeking your help to preserve the building and the memories it may contain even though they no longer go in it or even drive by it. Here are a few of the other reasons people have to save the church building.

They want the school to move out of the neighborhood because of traffic, noise, parking. For twenty minutes, twice a day there is traffic, This happens approximately 175 days per year. This happens near every school in St. Paul.

Some people aren't in favor of charter schools. Aren't they just tuition free (publicly funded) private schools?

Some people think this charter school is manipulating its test scores.

Some people question where this school obtained their financing and how they are spending it.

Dear Mr Gause:

I am writing you to express my strong support for nominating the building located at 1031 Como Avenue - the former St. Andrew's Church, now used by The Twin Cities German Immersion School – as a local historical landmark.

When my family moved to the Warrendale neighborhood almost 20 years ago, we were taken aback by the lovely sloping streets, older homes (ours was built in 1910), and amenities that have been well preserved that were in the neighborhood. The Streetcar Station was, at the time, park offices, but has been transformed into the lovely museum and D10 offices that are the center of social and political happenings in the area. The nearby streetcar/pedestrian bridge which was refurbished a few years ago is a lovely memorial to the city's early mass transit and nearby park features. The beautiful Lakeside Pavilion was not yet in use by Black Bear Crossing, but soon after was a wonderful example of using older spaces to meet current needs – a trend that continues today with its most recent tenant, Spring Café.

One additional piece of "history on display" is the former St Andrew's Church building. While no longer a church, it has stood prominently in the area with its beautiful exterior structures and notable tile roof for nearly a century. The rest of the property was rented out to several successive school and educational office tenants over the years. The building old school building was always occupied, much to our delight. When the entire property was sold, we were worried about the future of the site, but when it was purchased by another school, and they said that they planned to re-purpose the building, we were thrilled! There is something about having these lovely historical landmarks in this tiny corner of St Paul that connects one to the city itself. When we learned through the historic preservation study that it is "historic" on many different levels, that feeling of connectedness to the city made sense.

I am hopeful that your group will find this lovely piece of St Paul History to be eligible for Historic Designation. I also feel strongly that there can be a consensus as to its use by the current, or perhaps future owner/tenants that would allow for use and preservation.

I thank you and your team for their consideration and hard work on matters such as these; this is what makes St Paul great.

Dear St. Paul Heritage Preservation Commission Chair:

I am writing you to express my strong support for nominating the building located at 1031 Como Avenue - St. Andrew's, now occupied by TCGIS – as a local historical landmark.

St. Andrew's began as a mission church in 1895 and served for more than a century as the anchor for numerous working class and immigrant communities in the growing Capital City. The importance of the historical and culture value of St. Andrews can't be overstated, it's legacy runs deep in the community.

Charles Hausler (1889-1971) wore many professional hats as an engineer, architect, senator, deputy sheriff. Charles Hausler was considered the leader among architects in St. Paul with unusual talent.¹ Haulser was licensed as architect in 1908 and was licensed in MN/ WI/ ND/ SD, MT and FL. In 1915, Hausler hired Clarence "Cap" Wigington as a senior draftsman. Wigington was an African-American architect and is recognized as the nation's first black municipal architect. Hausler also appointed William M. Godette as junior architect. The Commissioner and Haulser were given credit for their 'broadminded action' regarding this appointment. Godette was the second African American hired by Hausler, not a standard practice at the time.

Charles Hausler, the Father of "building codes," wrote St. Paul's first building code in 1921. Safety was key in his designs, he preferred one-story schools because children could get out quicker in the event of a fire. He preferred concrete over steel, because steel could bend and lose its strength in a fire whereas concrete would not.

St. Andrew's was extensively surveyed by a reputable team of historical architects and is deemed eligible to be listed as a local *and* a national historic building. I urge you to vote in favor to make St. Andrew's as a historical landmark to the St. Paul City Council.
