The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The Variance shall be for the hours of 8:00 a.m. to 1:00 p.m., with a pre-event sound check at 7:45 a.m., on Saturday, May 11, 2019. 2. All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:00 p.m. on the event date.
