Dear Saint Paul Property Owner,

You are receiving this letter because you have indicated to the City that you believe the delinquent charge for garbage services at your property 812 CALIFORNIA AVE W is in error. We have reviewed your request and have determined that the charge for your garbage service was not made in error. The following is the reason for the charge.

## **REASON FOR CHARGE:**

According to the document you provided, you made a payment to Waste Management for \$96.08 on January 4<sup>th</sup>, 2019. This payment did not post to Waste Management until after January 5<sup>th</sup>, 2019.

Garbage haulers have turned all delinquent charges for Quarter 4 2018 (October – December) over to the City for assessment. When a delinquent balance is turned over to the City, your account with the garbage hauler will show a zero balance. The City is now responsible for collecting that amount. If the payment was not received by the hauler by January 5<sup>th</sup>, 2019, that payment was applied as a credit on your account. You are still responsible for paying the City any outstanding delinquent balance from Quarter 4 2018.

## **OPTIONS TO PAY YOUR BILL**

You can pay your bill before it is assessed to the property so it does not incur additional charges. Payment can be made by any of the following methods:

- 1. Pay online from your checking/savings account at <u>www.stpaul.gov/assessments.</u> No additional fee.
- 2. Pay online using a credit/debit card at <u>www.stpaul.gov/assessments</u>. Bank fee of 2.49%.
- 3. Pay in person with the City of Saint Paul Assessment Section at 700 City Hall, 15 W. Kellogg Blvd., St. Paul.
- 4. Mail payment to the address below and include your name and property address.
