# SUBJECT: Summary of the public process and comments received on the proposal for bicycle lanes on Larpenteur Avenue.

This memorandum presents a summary of the public process and comments received on Ramsey County and Saint Paul Public Works' proposal to install bicycle lanes on Larpenteur Avenue between Hazel Street and McKnight Road. The full text of all written statements received is attached to the end of this memorandum.

Ramsey County and Saint Paul Public Works staff began stakeholder outreach along Larpenteur Avenue in March 2019. A County website was created for the project, providing an overview of the planned improvements, visuals, timeline, and a project contact for questions and comments. City staff also presented the project to the Transportation Committee of the Planning Commission in March. The Transportation Committee recommended approval of the project as proposed.

#### **Larpenteur Avenue Project Meeting:**

A project meeting was held on April 3, 2019 at the Maplewood Community Center. Residents and property owners within 200 feet of the proposed project were sent notifications of the open house via mail, along with an overview of the project details and impacts. The postcards provided a map of the project, a link to the project website, contact information for project staff, and information about the project design.

#### **Written Statements Received:**

As of May 13, 2019, city staff received a total of 3 written statements specific to proposed Larpenteur Avenue resurfacing from the following sources:

- Comment forms from the project meeting (1 statement)
- Comments sent to county or city staff via email (2 statements)

It should be noted that the total number of statements received may include multiple statements from some individuals, as well as some duplicate statements (e.g. an individual may have provided written feedback at an Open House and provided feedback via email).



I am a resident of Maplewood and recently read in the Maplewood Review about this summer's resurface project on Larpenteur Ave. I have lived on Sterling Street for 37 years having been a teacher at Hill-Murray school for 40 years. As the work is being completed, for pedestrian safety reasons, I would like to see a crosswalk at the Larpenteur/Sterling Street intersection near the Hill-Murray baseball field. Students who bus ride for District 622 cross there each morning (walking from the housing/Common Bond) at Larpenteur and Century. Students walking to Hill-Murray also cross there in early morning hours. Once baseball season begins, most spectators park on Sterling Street and cross Larpenteur for baseball games. I believe you can agree that a crosswalk there is important especially for student safety.

Dear Saint Paul Resident / Property Owner:

Ramsey County is planning to resurface Larpenteur Avenue between Hazel Street and Century Avenue in 2019. The project will improve the pavement condition and upgrade curb ramps to meet ADA accessibility standards. Bike lanes will also be installed between Hazel Street and McKnight Road at the same time as the street resurfacing. To install bike lanes, parking removal is proposed for the north (Maplewood) and south (Saint Paul) sides of the street between Beebe and McKnight Roads.

This project will be presented to the Saint Paul City Council on Wednesday, May 15. **This will be a public hearing, and there will be an opportunity for public comment.** The City Council will be asked to approve a resolution supporting Ramsey County's proposal to add bicycle facilities and remove some on-street parking on Larpenteur Avenue.
