Hello Mai,

This email is regarding the legislative hearing scheduled for tomorrow, May 7th at 10am, for assessments to 286-288 Thomas Avenue West, St. Paul. I'm unable to attend the legislative hearing, but would like to submit this written statement regarding the matter.

There are 2 incorrect charges that are assessed to 286-288 Thomas Avenue.

1) Extra fees associated with the Certificate of Occupancy.

I have faxed in a "Change of Ownership form" several times for 286-288 Thomas Ave W, St Paul, MN 55103. See attached for a copy of the fax Cover Sheet and Change of Ownership form sent October 2018. Also see attached the proof that the fax was successfully sent to the intended recipient in Oct 2018. However the address was not updated in the City's system, despite my several communications with the City. I recently confirmed via email that the Owner Address has finally been updated (see attached email copy). However, because of the Ownership Address was not updated until recently, I did not receive the bill for the Cert of Occupancy, and did not have the opportunity to pay it. So I would like to pay the Cert of Occupancy fee in the original amount (\$264), without added fees (\$122 + \$35) being added to my taxes. See attached assessment notice.

2) Garbage Assessment

The garbage bill has been paid in full, as of April. When the City Garbage system switched from independent garbage providers to city-determined garbage providers, the new Garbage Company did not receive the accurate owner address from the city, so bills were sent to the wrong mailing address. When I learned of the billing mail mistake, I paid the garbage bill in full. See attached for screen shot showing a \$0 balance. The fact that everything has been paid can also be verified with Pete's Rubbish Hauling.
