As owner or person(s) responsible for: 1124 MATILDA ST you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

1. Remove snow and ice from public sidewalk full width including sidewalk ramp to street, salt and sand as needed. Comply before December 17, 2018

If you do not correct the nuisance or file an appeal before December 17, 2018, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

<u>Charges</u>: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.

You must maintain the premises in a clean condition and provide proper and adequate refuse storage at all times FAILURE TO COMPLY MAY RESULT IN A CRIMINAL CITATION

<u>APPEALS:</u> You may appeal this order and obtain a hearing before the City Council by completing an appeal application with the City Clerk before the appeal deadline noted above or seven (7) days after the date mailed, which ever comes first. <u>No appeals may be filed after that date. You must submit a copy of this <u>Summary Abatement Notice with your appeal application.</u></u>
