NOTICE OF PUBLIC HEARING

Sound Level Variance

MNUFC Gold Cup

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: 400 Snelling Ave. N. - Sprint Activation Area

Noise Source: Zacharia Litzelswope, Director of Events and Guest Experiences for the MNUFC, has requested a sound level variance, at a requested sound level limit of 105 decibels (dBA), at no specified distance, to provide the use of a sound system for a DJ booth and amplified musical performance for the Minnesota United FC Gold Cup. The amended variance application time is requested for the hours of 12:00 p.m. to 10:00 p.m., with a pre-event sound check at 11:00 a.m. on Tuesday, June 18, 2019. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 12:00 p.m. to 10:00 p.m., with a pre-event sound check at 11:00 a.m. for the Minnesota United FC Gold Cup on Tuesday, June 18, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA as measured at 50 feet from any sound source from 12:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on the date of the event.
