Thank you for the information! I have patients schedule that morning so cannot attend. Would it be useful for me to get information from Aspen to support my case? Or do you all have enough information?

To clarify: We called Aspen in January or February when we realized we still hadn't received a trash bill despite being Aspen customers prior to the change over to city-wide collection. Aspen told us that when they switched to city-wide they were sent the billing addresses by the city, and the billing address for our property was still listed as the forwarding address for the former owners of the house. So the bills were being sent to Alaska! Aspen updated the billing address and "forgave" the late fees that had accumulated, but apparently they had already sent some of the late fees to the city, which is why we have this assessment. We have paid our bill on time ever since getting the billing address corrected.

Thank you so much for your help in this matter- I'm sorry I'm unable to attend the hearings, but it is hard for me to get time off since patients are put on my schedule 2 months in advance.
