This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Description of Variance:

Location: CHS Field, 360 Broadway Street North

Noise Source: Tom Whaley, St. Paul Saints Baseball Club, Inc., has requested a sound level variance, at a requested sound level limit of 105 dBA at no specified distance from the sound source, in order to present live band amplified music with use of a Public Address System from 8:30 p.m. until 10:00 p.m., with a pre-event sound check from 3:00 p.m. to 5:00 p.m. on July 22, 2019 at CHS Field, 360 Broadway Street North. The Department of Safety and Inspections recommends the following conditions: 1) The Variance will be for live band amplified music with use of a Public Address System for the hours of 8:30 p.m. to 10:00 p.m., with a pre-event sound check from 3:00 p.m. to 5:00 p.m. on Monday, July 22, 2019 for the All Star Game Concert. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 95 dBA at 50 feet from the noise source from 8:30 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on Monday, July 22, 2019.
