## **NOTICE OF PUBLIC HEARING**

### Sound Level Variance

### Great Ward 2 BBQ

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** Parque Castillo – 149 Cesar Chavez St.

**Noise Source:** Friends of Rebecca Noecker have requested a sound level variance, at a requested sound level limit of 95 dBA at no specified distance in order to present amplified DJ music, with speakers, from 4:00 p.m. until 6:00 p.m., with a pre-event sound check at 3:30 p.m., on Sunday, August 4, 2019 at 149 Cesar Chavez St for the Great Ward 2 BBQ. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified DJ music with speakers for the hours from 4:00 p.m. to 6:00 p.m., with a pre-event sound check at 3:30 p.m., on Sunday, August 4, 2019. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 95 dBA at 50 feet from the noise source from 4:00 p.m. until 6:00 p.m., with a pre-event sound check at 3:30 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 6:00 p.m. on Sunday, August 4, 2019.
