NOTICE OF PUBLIC HEARING

Sound Level Variance Unlabeled Event Series – Upper Landing Park

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. <u>Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.</u>

Description of Variance:

Location: Upper Landing Park

Noise Source: Gray Duck Media, Growler Magazine has requested a sound level variance to present music and announcements for the Unlabeled Event Series at Upper Landing Park. The variance is requested at a sound level limit of 85 dBA, at no specified distance, for the hours of 5:30 p.m. until 9:30 p.m., with a pre-event sound check between 2-4:30 p.m., on the revised date of Friday, September 20, 2019. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The Variance shall be for the hours of 5:30 p.m. to 9:30 p.m., with a pre-event sound check between 2-4:30 p.m., with a pre-event sound check between 2-4:30 p.m., on Friday, September 20, 2019. 2. All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:30 p.m. on the event date.
