Description of Variance:

Noise Source: Dual Citizen Brewery has requested a sound level variance, at a requested sound level limit of 92 dBA at 100 feet, to provide the use of a sound system for amplified music for the Dual Citizen Block Party-Blocktoberfest. The variance is requested for the hours of 12:00 p.m.to 9:00 p.m., with a pre-event sound check at 10:00 a.m., on Saturday, September 14, 2019. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 12:00 p.m. to 9:00 p.m., with a pre-event sound check at 10:00 a.m., for the Dual Citizen Block Party on Saturday, September 14, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 92 dBA as measured 50 feet from any sound source.

3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. The applicant may need to provide a barrier, to act as a sound absorber, to contain excess sound from leaving the area 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 p.m. on the date of the event.
