Thank you for the response. My phone call was concerning 4<sup>th</sup> quarter 2018, but now the conversation has morphed into 1<sup>st</sup> quarter 2019 and then soon to 2<sup>nd</sup> quarter 2019. Below is the email chain with Mai.

At the last meeting I attended, the judge/council sent people, including the hauler, to the look at the property & determine where I could use all 3 cans. They agreed that there is room for 3 small cans, which is what I have been asking for & willing to accept, since last August. At that time, the hauler said I could only switch can sizes in January, in which I said I will only pay for the two medium cans in use. They told me I had to pay for all 3 & so I paid for none, and have been waiting my turn with the council. In January, I called them to get the cans switched out to the smaller size. They refused to swap the cans until I paid for 4<sup>th</sup> quarter 2018. So again, I have been waiting my turn with the council. Because this has been an on-going issue for 6 months, I did pay for the two medium cans in use for 1<sup>st</sup> & 2<sup>nd</sup> quarter's 2019. When all agreed the smaller cans would fit, I followed up with Advanced disposal on June 13th, and they swapped out the cans on June 17<sup>th</sup>. They wouldn't do this until after the council got involved. Today, I received a new bill from Advanced for July service. They are still charging me for 3 medium cans and the price has increased 39%!

So, this is still my offer, which is a fair as it can be:

I did not pay anything for 4th quarter 2018.

I paid \$192.18 for the two medium cans in use for 2019 Quarter 1 &

I paid \$192.18 for the two medium cans in use for 2019 Quarter 2.

I owe 4th quarter 2018 of \$210.96, plus 1st quarter 2019 of \$18.78 & 2nd quarter 2019 of \$18.78.

I have been working on this resolution before the very 1<sup>st</sup> pick-up, and do not believe the late fees should have incurred.

Please tell me whom I need to see or speak with to get the \$ amount adjusted, and get current for Oct 18 -June 19. I will pay this immeadiately, if agreed upon.
