Sound Level Variance Radio Five Watt Music Fest

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: Keg and Case Market – 928 7th St. W.

Noise Source: Caleb Garn, Keg & Case Coffee LLC, Five Watt Coffee, has requested a sound level variance, at a requested sound level limit of 90-100 decibels (dBA), at no specified distance, to provide the use of a sound system for live music for the Radio Five Watt Music Fest. The variance is requested for the hours of 10:00 a.m. to 5:00 p.m., with a pre-event sound check at 9:00 a.m. on Sunday, September 8, 2019. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 10:00 a.m. to 5:00 p.m., with a pre-event sound check at 9:00 a.m. for the Radio Five Watt Music Fest on Sunday, September 8, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 decibels as measured 50 feet during the pre-event sound check from 9:00 a.m. until 10:00 a.m. and shall not exceed 90 dBA as measured 50 feet from any sound source from 10:00 a.m. until 5:00 p.m. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. The applicant may need to provide a barrier, to act as a sound absorber, to contain excess sound from leaving the area 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 5:00 p.m. on the date of the event.
