- In May, I started to receive notices from the city that due to non-payment, they will assess my property unless I pay, see attached
- I called the city ... they ran me in circles through multiple departments then said "too bad, you will have to go through the process to fight the assessment. You should call Republic"
- I've called Republic Services Customer Service at least 6 times over the last 4 months and I speak with some very nice people and several times I've been told "I'll take care of it" please look up the case notes. But no one ever takes care of it and I keep getting the attached notices from the city. Apparently someone is working on it right now ... but I've been told that before and this time they finally gave me your email and said that you can reach out to the city directly
- Now they have given me a final notice and told me I have to come to a hearing but both my wife and I travel and we can't make that date. Even if we did I'm doubtful they will help me anyway – they just want their money
