The second round of voting finished up last week, with Trout Brook coming out on top.

Bode said he was inspired by the proximity to the stream and how it shows SPRWS' commitment to protect and care for all waters within our properties and system. The utility releases more than 1.5 million gallons of water a day into the brook as it flows south to the Mississippi River. The water discharged by the SPRWS to Trout Brook is of high quality, supporting wildlife and the efforts to restore the ponds and wetlands downstream.

Hands-free driving now in effect

Hands-Free driving laws went into effect August 1 that require drivers to keep their hands off their phones while in the car.

If you talk, text, or listen to music from your phone, it must be done by voice command or single-touch activation.

Drivers cannot hold onto the phone, or use it for video calling, live streaming, social media, gaming, videos, phones, reading texts, scrolling or typing.

If you break this law while driving a company vehicle, all fines are your personal responsibility.

The first ticket is \$50, subsequent tickets are \$275. That does not include citations for distracted and unsafe driving, court fees, or other costs.

Water Works gave out grants worth \$30,448 in 2018

Every summer, the water utility asks its customers to contribute to *WaterWorks*, a program that assists needy residents with their water bills. *WaterWorks* is jointly administered between the water utility and the Community Action Partnership of Ramsey and Washington Counties (CAP).

Customer contributions provided \$30,448 in grants to customers in need in 2018. This amounted to 148 grants, with the average amount of the grant being \$176. A grant assists the customer in need with paying the water and sewer bill to ensure that they continue to receive water services. This might be an individual, a family or another adult with dependents. So, while 148 grants were provided, your contributions kept more than 148 people supplied with water service.

Applicants must meet certain criteria to receive the grants, which include water service termination or pending termination, financial crisis, and qualification under low-income guidelines. Grants have annual limits and are subject to availability of funds. CAP determines whether a customer qualifies under Minnesota state median income guidelines from the US Department of Health and Human Services.

The program received \$30,448 in contributions last year, of which \$5,000 came from matching funds from SPRWS. The remainder of the funds came directly from customer contributions. One-time contributions totaled \$5,649 while on-going contributions totaled \$19,799.
