
I am writing to express my strong support of Mayor Carter's plan to reduce car traffic lanes on Ayd Mill, and specifically to support the inclusion of bicycle and pedestrian infrastructure. I'm guessing some people will be uncomfortable with this change, but I support the city council's stated goals to look toward our future - not toward our past.

Ayd Mill is vastly overbuilt for the amount of traffic it gets, and currently is only usable by people who are driving cars, which is an incredibly inequitable use of our city's resources. Transitioning this space from 100% car-dedicated to a complete street with walkable areas and bicycle infrastructure will be hugely beneficial to our city. This is a small step toward many big goals our city has, which are specifically laid out in the 2040 Comprehensive plan, including climate change resiliency, equity, health, and innovation.

I am personally impacted by the current state of the road, and the plans for it's future. I live on Saint Clair Ave, 1.5 blocks away from Ayd Mill, and do not own a car. Right now, Ayd Mill is just a big barrier to me - I can't use it, and there's no easy way to go around it or across it. The current state of Ayd Mill disrupts our street grid and fragments my neighborhood. As you can see on my map below, there is currently NO north/south bicycle infrastructure in this area, and it's largely because of Ayd Mill and it's car-only status.

Ayd Mill can be an invaluable connector for people who live right here, in our city - we just have to build it for multiple modes of transportation, and create strong connections to our streets.

My family and I reside at 1452 Ashland Avenue, which is only a few short blocks from the northern "terminus" of Ayd Mill Road as the flow of traffic then filters up to I-94. This is a problem area. In fact, a Stop For Me event was held in July at Saratoga and Selby, and many motorists failed to stop for pedestrian in the well-marked crosswalk. I cross this intersection daily with a baby in a stroller. It is hazardous. This is obvious to anyone who has cross this on foot or bike. Or car for that matter.

I am writing in SUPPORT of Mayor Carter's plan to reconfigure Ayd Mill Road to a more reasonable, and city-street-like, 1x1 lane configuration. It is well documented that this will reduce long-term wear and tear costs, as well as promote local property values (e.g., mine) in the area. Ayd Mill Road is only rarely crowded as it is and only in certain rare times would a second lane even get used at present. There are so many reasons to love and support this idea:

- \* It's fiscally responsible. Maintenance of Ayd Mill Road in its current formation is a money pit. We need to put our resources toward other needs. This configuration is a good compromise between closing it down and putting more money than we have into maintaining all four lanes.

Hello Councilmembers,

I've reached out to the Mayor's office and my specific council representative with this, but wanted to contact you as a group as well. As a resident of Ward 1, and lucky enough to live on Lexington Pkwy so near the Ayd Mill Road, I was thrilled to hear the Mayor's vision to reduce AMR down to two lanes for vehicle traffic, and convert the other lanes to bike/pedestrian usage. I hope this is one more of many positive messages you're receiving in support of this plan. I also hope you will work to support this vision, and help to make this a positive change for Saint Paul.

While I do use AMR to connect quickly to/from 35E, there's absolutely no need for the existing 4 total lanes of traffic for this purpose, going at 45 MPH for a relatively short stretch. I would love to see the lanes reduced and the speed limit reduced, both for greater safety and for less wear/tear on the roads, which should hopefully reduce long-term maintenance costs as well. The mayor's vision still allows cars to use AMR to get to/from 35E if necessary, while making space for other usages as well.

A couple years back I ran the Twin Cities Marathon, and during my training runs I frequently ran on the Minneapolis Greenway - it was alive with bikers and runners and walkers with dogs, and it was a joy to run on without having to worry about crossing streets and whether someone might drive their car into me. Additionally, the Greenway has become a development corridor, bringing new businesses and people along it's length. I would love to see Ayd Mill Road turn into a similar asset to Saint Paul, and our neighborhood - I dream of a day I can run, walk, or bike along Ayd Mill road, and either head to downtown Saint Paul easily, or connect to the Minneapolis Greenway. Or perhaps, stop at a new brewery, bookstore, restaurant, etc, along AMR. It would be such an asset to our neighborhood, and a great way to link our two cities together further.

If anyone is complaining that there might be increased traffic along neighboring streets as a result of this change - as someone who lives on Lexington Pkwy and might be on the receiving end of increased traffic, I'm not worried about it. Dear St Paul City Council Members,

I <u>strongly oppose</u> the proposed budget allocation and changes to Ayd Mill Road that would reduce the roadway from 4 to 2 lanes.

I am a 35 year resident of St. Paul living in Ward 3 at 1451 Sargent Ave. between Snelling Ave. and Ayd Mill Road. I drive a car, use a bicycle and at times use public transportation.

I strongly oppose the proposed change for the following reasons:

- 1. Keep traffic moving through the neighborhood, not in the neighborhood. Ayd Mill is now a primary artery for moving traffic from 35E to 94. Much of that traffic moves suburban commuters as well as St. Paul residents working in southern suburbs more quickly through the city without using residential streets. It provides ample access for St Paul residents to travel more efficiently through this part of the city and to access 35E. Maybe many supports of the change have short memories or did not live here before Ayd Mill was opened to 35E, but the traffic congestion on Lexington, Snelling and other residential streets was intense. This was especially true at Lexington and Randolph and that was before Trader Joe's traffic issues where there. When Ayd Mill opened up there was noticeable reduction of congestion. And logically, I believe reduced wear and tear on residential streets and it made the neighborhoods safer. Unless there is a study that proves otherwise, reducing Ayd Mill to 2 lanes will not eliminate the traffic, rather it will greatly increase congestion at entry/exit points and will divert traffic back to the residential streets which are already in rough shape. Thinking that drivers will find alternative routes that require more time and distance is just wishful thinking.
- 2. If it is not broken, don't fix it. What is the problem you are trying to fix by reducing traffic lanes on Ayd Mill? I am still trying to understand what is broken and what we're trying to fix. Yes, Ayd Mill needs resurfacing and/or some reconstruction, but reducing the roadway to 2 lanes is solving what problem? Yes, bike and pedestrian paths are nice amenities, but not at the expense of reducing traffic flow on a major artery through the city, increasing

traffic congestion, and diverting traffic onto residential streets. I use the great bike lanes we have in the city, but don't support building another if it means taking away lanes of Ayd Mill. I expect any commuter bike traffic here would be minimal. I believe the 'original' plan for the Ayd Mill artery (during then Mayor Kelly's admin. when the plan filed with the Feds. was supposed to be permanent) included a bike and pedestrian plan east of the railroad tracks. What happened to that? It's another issue, but there was a real flaw with the original 35E design not to have it connect to 94. The current Ayd Mill Rd is the best option there is until a direct connection to 94 can be achieved. Could that be part of the 94 redesign project?

3. Use what budget there is to first repair and/or replace St. Paul's crumbling residential streets. I do not know where in the budget the dollars for the Ayd Mill project are allocated, but please do not move forward with this project if they come from the same budget as public works for current city streets and roadways! It is the end of August and most of the potholes on residential streets north of St. Clair between Snelling and Hamline have yet to be repaired! Over the years it seems the streets continue to deteriorate without adequate repair or replacement. We now have near third-world infrastructure within the city. I am actually embarrassed to have guests from out of the city drive to my home and have to apologize for the streets. Like others, I have seen exceeding high tax increases in recent years and do not see any improvement or adequate up keep to maintain city infrastructure. As a tax payer and retiree, I'm about at my limit for tax increases. Please make fixing current city streets a priority over allocating my tax dollars to an Ayd Mill redesign project that maybe nice, but is not necessary or broken at this time.

Again, I **strongly oppose** the proposed change to and budget allocations for Ayd Mill Road.

### Good Afternoon.

I am a longtime resident of St. Paul (currently in the Midway neighborhood), but have lived in Merriam Park/Mac Groveland before. I commute to work daily on Ayd Mill to get to 35E.

Each morning and afternoon the road is filled with cars. While this isn't bumper to bumper traffic, there is a steady flow of vehicles. The area, specifically Snelling and Selby is becoming more and more dense and traffic in Mac Groveland is becoming more of an issue.

While I am for bike infrastructure, and commute via bike as well as car, I think narrowing the road to add bike lanes would be detrimental to the neighborhood. The neighborhood streets will not be able to absorb this traffic and both the residents of the area and daily commuters from other parts of the city will suffer.

A right-sized solution would be to repave the road as is and add a sidewalk or *one* protected bike lane on one side or the median, and perhaps lower the speed limit of the road to make it safer for everyone. There is plenty of room! Ayd Mill is only 1.5 miles long and ends at an interstate. It will not become a key transit way in terms of bike infrastructure and will not attract enough bikers to warrant individual bike lanes in each direction. There are not enough attractions and businesses along Ayd Mill and the side streets to warrant the suggested infrastructure changes. You can't create a 1.5 mile bikeway and have it dump people out onto the interstate.

Hi all,

Mary Ellen and I have lived near Lake Phalen for 42 years. We biked the Gateway north of our home with our children - before it was the Gateway. As a 3M bike club member our family biked from the campus to Como Lake and back, with our 6 year old son leading the way on his single speed bike. Our daughter, son and son in law have biked to their work in Anchorage, Albuquerque, Ha Noi, Minneapolis and St Paul, as did I to the tower at 3M Center. Mary Ellen used to walk the railroad bed (now Phalen Blvd.) to the 3M engineering building to her office.

We've been St Paul Classic volunteers for over a decade and BikeMN members. Through this statewide organization I became aware of the Midtown Greenway Coalition and attended their initial meeting about the rail bridge across the Mississippi.

Mayor Carter's plan can potentially connect with the Midtown Greenway trail in Minneapolis. The Midtown Greenway Coalition has been advancing a campaign called "Extend the Greenway," which would add a new section to the famous bike trail over the Mississippi River and eventually into Saint Paul. The current proposed route would meet up with Ayd Mill Road, providing one more option for bikes that avoids biking on streets.

As a SPPD Stop For Me Steering Committee member and Payne Phalen Community Council member, and Jim McDonough's neighbor, I helped Ramsey County make Maryland Avenue's traffic predictable and less likely to create a serious injury. An argument against the 4 to 3 lane conversion raised by traffic engineers was a fear of increased traffic on Rose and Hawthorne. Similar to the worry about traffic rerouting off Ayd Mill. It didn't happen. Average speed was reduced from close to 40 mph to close to 30 mph and the weaving of speeders ended. Such a simple engineering fix, which the education/enforcement piece we did at Greenbrier and Maryland one month before the death of a pedestrian on the "Maryland 500" didn't accomplish. Let's help drivers be safer on Ayd Mill.

The cost of maintaining our streets will be reduced by making half of Ayd Mill a bike and pedestrian space. Let's see how it works. The naysayers on Maryland were wrong, if safety and people first transit is what we want for St Paul. Just as congestion happens on Maryland at rush hour, that's when drivers will line up here, but at a safer rate of speed. If this reduces traffic volume we can consider it part of our Climate Action Plan. If we don't make intelligent change, our climate will make the change for us.

I have 4 meetings between 3 and 10:30 Wednesday so I won't be there with my tshirt and bike and pedestrian pins. Just picture me sitting with those pesky St Paul Bike Coalition folks.

As a senior citizen who has been car free for 39 of my 66 years of life, and involved with active transportation and volunteer work for a long time, I was very impressed and thrilled to hear Mayor Carter's plan to re-configure and re-design the road to include protected space for walk and bike. This plan will provide full, protected space for walk, bike and handicapped mobility on a through space that follows the alignment that can connect with the Midtown Greenway in Minneapolis. In addition, the 22 to 24 feet of the eastern road space will provide adequate clearance to stripe separate space for walk and bike with two separate lanes for the bicycle.
