NOTICE OF CONDEMNATION UNFIT FOR HUMAN HABITATION ORDER TO VACATE

RE: 275 MCKNIGHT ROAD S

Ref. # 11287

Dear Property Representative:

Your building was inspected on August 30, 2019.

The building was found to be unsafe, unfit for human habitation, a public nuisance, a hazard to the public welfare or otherwise dangerous to human life. A Condemnation Placard has been posted on the building.

The following deficiency list must be completed immediately.

CONDEMNATION OF THE BUILDING REVOKES THE CERTIFICATE OF OCCUPANCY.

Failure to complete the corrections may result in a criminal citation. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy.

DEFICIENCY LIST

- 1. THROUGHOUT SPLC 34.23, MSFC 110.1 This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office.
 - -All tenant spaces at this property have been condemned due to a lack of basic facilities. The water service has been shut off to this building due to a private sewer line break.

- 2. THROUGHOUT SPLC 34.11 (4), 34.35 (1), MPC 708.1- Connect or cap the sewer piping in accordance with the plumbing code.

 -Repair or replace the broken private sewer line. All work must be done by a qualified contractor and under permit. Tenant space 275 has a large access hole approx. 8 to 10 feet deep in the middle of the mercantile space with inadequate safeguards for the public.
- 3. THROUGHOUT SPLC 34.11(4), 34.35(1), MPC 601.1 Provide an adequate water supply to all water closets, sinks, showers and tubs.

 -The water service to the building has been shut-off. Restore the water service to the building.

You have the right to appeal these orders to the Legislative Hearing Officer.
