## **NOTICE OF PUBLIC HEARING**

### Sound Level Variance Meritage Oysterfest 2019

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** Meritage Restaurant, 410 St Peter Street, with stage music at Hamm Plaza, 99 6<sup>th</sup> Street West  
**Noise Source:** Meritage Restaurant has applied for a sound level variance, at no requested sound level limit or distance in order to provide outdoor music on stage at Hamm Plaza, 99 6<sup>th</sup> Street West, by Meritage Restaurant, 410 Saint Peter Street during their Oysterfest 2019, on Sunday, October 13, 2019 from 12:00 p.m. to 6:00 p.m., with a pre-event sound check at 11:00 a.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The Variance shall be for the hours of 12:00 p.m. to 6:00 p.m., with a pre-event sound check at 11:00 a.m., for live music at Hamm Plaza, 99 6<sup>th</sup> Street West, on Sunday, October 13, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for amplified music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 6:00 p.m. on Sunday, October 13, 2019.
