NOTICE OF VIOLATION AND RECOMMENDATION FOR IMPOSITION OF \$200 MATRIX PENALTY FOR SALE OF TOBACCO TO A MINOR AND \$500 MATRIX PENALTY FOR SALE OF FLAVORED PRODUCTS

Dear High 5 Inc.:

The Department of Safety and Inspections ("Department") will recommend adverse action against the Cigarette/Tobacco license held by High 5 Inc. ("Licensee") for the premises known as SNAP Market located at 957 Rice in Saint Paul. ("Licensed Premises").

Sale of tobacco to an underage person is a violation of both Minn. Stat. § 609.685 and Saint Paul Legislative Code § 324.07(d).

Saint Paul Legislative Code §324.11(b)(1) provides for a presumptive penalty of \$200 for a first-time violation for the sale of tobacco to an underage person.

Saint Paul Legislative Code §324.07(f) prohibits a licensee from offering for sale, selling and distributing flavored products.

Saint Paul Legislative Code \$310.05(m)(2) sets the penalty for a first-time violation of a provision of the legislative code relating to the licensed activity at \$500.

The Department asserts the following facts along with attachments herein constitute proof of a violation of Saint Paul Legislative Code §§'s 324.07(d) and 324.07(f) by a preponderance of the evidence.

On June 16, 2019, at approximately 1:33 p.m., DSI Inspector Muhammad conducted an underage tobacco compliance check at SNAP Market located at 957 Rice Street in the City of Saint Paul. DSI Inspectors use underage cooperating individuals (UCI's) who carry valid Minnesota picture ID's with "UNDER 21" clearly printed above their pictures when they conduct these types of compliance checks. The UCI was told to go into the store and attempt to purchase tobacco.

The UCI entered the store and requested Marlboro cigarettes. He walked to register and the clerk later identified as Al Easar Khalid Riyadh rung up the purchase.

The UCI left the store and turned the Marlboro cigarettes and change over to DSI Inspector Muhammad.

DSI Inspector Muhammad went back into the store and identified himself as DSI Inspector who was conducting underage tobacco compliance checks. DSI Inspector Muhammad informed Al Easar Khalid Riyadh that he had failed the compliance check by selling to an underage person.

Al Easar Khalid Riyadh denied selling the cigarettes and would not give Inspector Muhammad his identification. Al Easar Khalid Riyadh called the owner and Inspector Muhammad spoke with him, explained what happened and that he needed to document this violation. The owner spoke with Al Easar Khalid Riyadh who then provided his identification so that Inspector Muhammad could document the violation.

While he was behind the counter Inspector Muhammad observed and documented the following prohibited flavor products: Black and Mild Wine, Zig-Zag Grape, Zig-Zag Slo Burn Grape, Zig-Zag Cigarillos, White Grape and Double Platinum KUSH. Inspector Muhammad informed Al Easar Khalid Riyadh that these items were a violation of Saint Paul Ordinance 324 and needed to be removed from the store.

As the Licensee you have four (4) options:

- 1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **Friday, August 30, 2019**, I will presume that you have chosen not to contest the proposed adverse action and the matter will be placed on the City Council Consent Agenda for approval of the proposed remedy.
- You can admit to the violation and pay the \$200.00 matrix penalty. If this is your choice, send the payment directly to DSI at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Friday, August 30, 2019. A self-addressed envelope is enclosed for your convenience. Payment of the \$200.00 matrix penalty will be considered a waiver of the hearing to which you are entitled.

- 3. If you wish to admit the facts but you contest the \$200.00 and \$500.00 matrix penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **Friday**, **August 30**, **2019**. The matter will then be scheduled before the City Council to determine whether to impose the \$200.00 and \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 4. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **Friday**, **August 30**, **2019**. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

<u>Please note:</u> If you choose an administrative hearing, the Department of Safety and Inspections reserves the right to request that City Council impose the costs of the administrative hearing, per Saint Paul Legislative Code § 310.05 (k).

If you have not contacted me by Friday, August 30, 2019, I will assume that you do not contest the imposition of the \$200.00 and \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.

Details of Conversations (Statements to and by Person Responsible for Property After failing a tobacco age compliance check. I went into 957 Rice St. Upon arrival for a tobacco age compliance violation follow up. I Akbar R. Muhammad, an inspector for the DSI, introduced myself as inspector from DSI to the clerk. Mr. Rivdh, I asked if he sold the Marlboro 20 class A cigarettes to the under age decoy, I gave a physical description of the under age decoy and showed him the pack of Marboro 20 class A cigarettes along with the change that he had given the under age decoy. At first, he denied seeing the decoy and also selling him the pack of cigarettes. After explaining to the clerk that he had indeed sold the decoy the cigarettes, he said he would call the owner. I spoke with the owner over the phone and described the situation. I also told him that the clerk was refusing to give me his photo I.D. I explained that I would need his photo ID to complete and document the violation. The owner talked with the clerk and he at that point handed over his ID. As I was behind the counter, I observed the following flavor violations: Black and Mild WINE. Zig-Zag GRAPE. Zig-Zag SLO BURN GRAPE, Zig-Zag Cigarillos WHITE GRAPE, and Double Platinum KUSH. I advised Mr. Rivdh these were all violations and needed to be removed asap to be in compliance with ordinance 324.

Dear Cigarette/Tobacco License Holder,

The Saint Paul Legislative Code establishes minimum cigar prices, prohibits the sale of flavored tobacco products at most retail locations, limits the size of temporary window signs in stores, and regulates customer access to the tobacco and tobacco-related products on display. Compliance checks for these items are typically conducted a minimum of once per calendar year where tobacco, tobacco-related devices, electronic delivery devices, or nicotine or lobelia delivery products are sold. These checks consist of a DSI Licensing Inspector visiting the establishment unannounced then observing product placement and labeling, speaking with clerks, taking photos, etc. to monitor for compliance with retail tobacco requirements.

Please consider this letter formal notice that the Department of Safety and Inspections (DSI) will begin to conduct the 2019 routine compliance checks for eigar pricing, flavored tobacco, temporary window sign, and tobacco display requirements the week of April 8th and expects to complete the initial checks of all vendors by late May. Of further note, compliance checks may be conducted at any time during the year in response to complaints or reported violations of these or other applicable requirements. Ordinance violations will be forwarded to the City Attorney's Office for adverse action against your license(s) that will result in fines and potential license suspension.
