Noise Source: Zacharia Litzelswope, Director of Events and Guest Experiences for the MNUFC, has requested a sound level variance, at a requested sound level limit of 95 decibels (dBA), at no specified distance, to provide DJ Booth amplified music within the Beer Garden area for the St. Thomas vs. St. John's Football Game. The variance is requested for the hours of 8:00 a.m. to 6:00 p.m., with a pre-event sound check at 8:00 a.m. on Saturday, October 19, 2019. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 8:00 a.m. to 6:00 p.m., with a pre-event sound check at 8:00 a.m. for the St. Thomas vs. St. John's Football Game on Saturday, October 19, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA at 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 6:00 p.m. on the date of the event.
