## NOTICE OF PUBLIC HEARING

Sound Level Variance MNUFC Playoffs – Semifinals

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. <u>Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.</u>

## **Description of Variance:**

Location: 400 Snelling Ave. N. – In the Street and/or DJ Booth within the Beer Garden Area Noise Source: Zacharia Litzelswope, Director of Events and Guest Experiences for the MNUFC, has requested a sound level variance, at a requested sound level limit of 95 decibels (dBA), at no specified distance, to provide amplified music in the street and/or with DJ Booth amplified music within the Beer Garden area for the Minnesota United FC MLS Playoffs Game – Semi-Finals. The variance is requested for the hours of 3:00 p.m. to 10:00 p.m., on Wednesday, October 23, 2019 or Thursday, October 24, 2019. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 3:00 p.m. to 10:00 p.m. for the amplified music in the street and/or DJ Booth within the Beer Garden area for the Minnesota United FC Playoff Semifinals on Wednesday, October 23, or Thursday, October 24, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA at 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on the date of the event.
