On 6/23/18 at 0115 hours, I, squad 312 (Wallace) was dispatched to 1981 3 St E for a burglary report.

I spoke with the complaint, identified as TAIWO ABOSEDE REUBEN (1/09/1977, 1760 FERNWOOD APT 201, ROSEVILLE, MN, C/P: 818-399-3791). REUBEN stated that it was her fathers house and that he was out of the county. She was alerted by her father that the alarm company (Front Point) had called and stated that they had alarms for the residence.
