HOTEL ZONING STUDY AND AMENDMENTS TO ZONING CODE CHAPTER 65 – LAND USE DEFINITIONS AND STANDARDS

WHEREAS, the Saint Paul City Council initiated amendments to Zoning Code Chapter 65, Land Use Definitions and Standards, to create a definition of hotel on January 2, 2019 in City Council resolution 19-41, and forwarded the proposed amendments to the Planning Commission for study and report as required under Minnesota Statutes § 462.357, Subd. 4; and

WHEREAS, the proposed Zoning Code Chapter 65 amendments regarding hotels and motels are needed in response to the code's lack of a definition of hotel or motel or any standards applicable to hotel or motel for any of the zoning districts in which the uses are permitted and a further consideration of the City Council in initiating the amendments is a concern for the loss of affordable housing that can result from the conversion of long term rental units to short term rental dwelling units in buildings providing naturally occurring affordable housing; and

WHEREAS, the Planning Commission held a public hearing on the Hotel Zoning Study and Amendments to Chapter 65 – Land Use Definitions and Standards on September 20, 2019; and

WHEREAS, the Comprehensive and Neighborhood Planning Committee, on October 2, 2019, considered the public hearing testimony, reviewed the proposed zoning code amendments, and forwarded its recommendations to the Planning Commission; and

WHEREAS, the Planning Commission considered the recommendations of the Comprehensive and Neighborhood Planning Committee at its meeting on November 1, 2019;

NOW, THEREFORE, BE IT RESOLVED, under the provisions of Zoning Code § 61.801(a) and pursuant to provisions of Minnesota Statutes § 462.357, that the Planning Commission recommends to the Mayor and City Council the following amendments to Zoning Code Chapter 65, including the rationale as articulated in the October 11, 2019 memorandum from the Comprehensive Neighborhood Planning Committee to the Planning Commission.
